

QuickScreen Batch from 700Credit

QuickScreen Batch is a platform that enables dealers to manually upload a customer list to their 700Dealer.com portal and run a batch of prescreens processed overnight, with results available the following morning.



How it Works

QuickScreen Batch is an add-on solution for customers currently using the QuickScreen, prescreen platform. Running prescreens in a batch process allows for a lower price point for the same consumer credit data available, run in real-time.

Batch prescreens still require firm offers of credit to be delivered by the dealer. If an email address is provided in the upload, the offer will automatically be delivered via email. If a consumer passes a prescreen and the firm offer of a credit letter is not printed or emailed, the 700Credit mail house will automatically send the letters.

There are 2 locations in the 700Dealer.com portal where dealers can view their QS Batch results:

- New QS Auto Trade Summary Report under Usage Analysis

- ✓ To run batch prescreens on your sales database for remarketing to customers who didn't purchase, or haven't purchased for a while
- ✓ To run batch prescreens on purchased sales leads before you reach out to the prospect
